D. REPORT OF THE BOARD PRESIDENT (Mr. Alley)

Mr. Alley congratulated the two new Trustees. Amy Huntsinger was appointed as the new Student Trustee. He noted that several years ago Amy's brother, Doug Huntsinger served as Student Trustee. We are pleased to have Amy with us and know that she will do an excellent job.

Joyce Rogers our other new Trustee is CEO of Indiana Black Expo. Joyce was unable to be with us today since her duties with Black Expo require her to be in Indianapolis at this time. She will provide excellent counsel and leadership to us.

Board members had an opportunity to have lunch with Support Staff Council officers after the Board meeting last month. This is a great way for Trustees to get feedback from the Council and to get to know some of the campus leaders personally.

The assembling of the Presidential Search Committee has begun. Trustee Carpenter will serve as Chair of the Committee. We have asked a number of persons engaged with the University to identify individuals that will appropriately represent them as we begin the search. The Search Committee has not yet been assembled, but it will be done in the appropriate fashion and will follow all the rules and regulations. Mr. Alley expressed thanks to Melony Sacopulos for her help in the process.

E. REPORT OF THE FACULTY SENATE CHAIRPERSON (Dr. Lamb)

Good morning Trustees, President Benjamin, good morning all and a special welcome to Trustee Rogers and Student Trustee Huntsinger. The University community appreciates your service and we look forward to working with you.

I would like to congratulate all of those involved with the enrollment effort this academic year. The latest undergraduate admissions report gives us an upbeat projection. As of July 15, we are 11% ahead of where we were last year at this time, and 25% ahead of two years ago. Enrollment efforts are critical to the health and well-being of the institution. The efforts of all, staff and administration, working together, have been exceptional.

Little Faculty Senate action occurs during the summer, though the current and incoming officers have been preparing proposed slates for membership on each of the faculty standing committees identified in Appendix B, Section IV of the Board of Trustees Policies and Procedures.

Virgil Sheets, Arthur Halpern, Blanche Evans, Alma Mary Anderson, Charles Hoffman and I have all been working diligently to staff each of these committees with appropriate knowledgeable faculty. Approximately half of the membership of these committees is appointed each year, and half carries over from the prior year to serve staggered two-year terms.

The membership of these committees must then be confirmed by the Faculty Senate (<u>Handbook</u> Article VII -- Section II) which occurs at the first meeting of the Senate in August. At that point the committees will be able to embark upon their charges, many of them specified in the Board-approved <u>Handbook</u>.

Representative governance can be cumbersome, but it is also the best means of achieving a functional system in which all parties have the opportunity for input, and thereby the prerequisite for the buy-in necessary to produce a cohesive and efficient academic unit. It is incumbent upon all parties to respect others to achieve a functioning, viable system.

It is my wish that the membership of the Presidential Search Committee be such that the long-term health and well-being of our institution is the primary and indispensable criterion above all other objectives. Personal agendas and interest have no place on such a committee.

This is the third time that I, or one of my dear colleagues, has indicated this was my last Board meeting. This, however, really is my last appearance before you this year. Regardless, I wish the Board and the institution continued success.

F. REPORT OF THE SUPPORT STAFF COUNCIL CHAIRPERSON (Ms. Hall)

Kelly thanked the Trustees and President Benjamin for their luncheon in June. Several different issues and concerns were discussed at that time. Uppermost were the issues of compensation, communication, and how we can market the Council. We look forward to working together to try to address those issues and concerns.

The annual Support Staff Council Retreat was held on July 13th at the Ohio Building. The Retreat this year focused on Representatives. What being a representative of the Council means and what they can do to be better representatives of their districts. Better communication to the staff in their districts and how to market the Council and what we do was a hot topic of discussion. Training was given by LaNecca Williams of Affirmative Action on the matter of Sexual Harassment. Mark Frederick from the Career Center, conducted a program on ICARE (problems and how to come up with solutions). Finally, a game of Deal or No Deal focused on teamwork. A good time was had by all.

The Retreat ended with a ceremony honoring our Support Staff Scholarship recipients. The Scholarship committee this year presented a record eleven scholarships. Ten \$300 scholarships were given and the John and Jacqueline Phillips Scholarship for \$600. A list of the recipients can be found on the Support Staff Council website. The record number of scholarships given was made possible by the proceeds from the Soup and Sandwich fundraiser and very generous donations by the President, staff and faculty.

This afternoon most of us will be attending the Recognition of Service Ceremony. The Ceremony honors those staff members with 5 to 35 years of service to the University. This year a total of 148 staff members are being honored. We will also be honoring eleven Medallion Award recipients. This award is presented to those showing exceptional service and dedication to the University. Kelly said again this year she will be the MC for the event and is looking forward to presenting these awards.

G. REPORT OF THE STUDENT GOVERNMENT ASSOCIATION PRESIDENT (Mr. Patton)

Mr. Patton congratulated Amy Huntsinger on her appointment as Student Trustee and to Joyce Rogers, CEO of Indiana Black Expo. He also thanked Dr. Lamb for his service.

A.J. reported that SGA is working with Mark Frederick, of the Career Center, on planning events that will occur when the students come back to the campus.

I would like to welcome our new Trustees Joyce Rogers and Amy Huntsinger. Joyce could not be with us today as her duties with Black Expo require her presence in Indianapolis. However, while both Joyce and Amy are new to the Board, they are certainly not new to Indiana State. We welcome Joyce, back to her alma mater in this new role. Amy, we look forward to having you represent our students as our newest Trustee although not the first in the Huntsinger family.

I would also like to congratulate Ron Carpenter and Norm Lowery on their reappointments to the Board.

Events

Today we will be celebrating two very significant events. Following our meeting this morning, we will be officially breaking ground on the new Student Recreation Center. This facility will have a tremendous impact on our students and should become one of the most popular locations on campus. I am looking forward to participating in this long-awaited event and would like to express our appreciation to everyone who has made it a reality. We will speak in much greater detail about the facility and those involved at the ceremony at 10:30 a.m.

This afternoon, we will gather once again, this time to recognize 148 employees who have reached milestones in their years of service to Indiana State University. In addition, we will honor 11 individuals with the University Medallion. We look forward to recognizing these members of our support staff and our executive, administrative, and professional staff for their outstanding dedication to Indiana State University.

National Fellowship

In other good news items, it is my pleasure to report that one of our doctoral students has been recognized by a national organization of scientists for his research.

The American Society of Mammalogists has awarded Justin Boyles its 2007 Fellow in Mammalogy in recognition of his research on bats. The fellowship

provides \$18,000 to release Justin from his teaching duties so that he may devote more time to his research. Only one such fellowship is awarded each year.

A native of Osceola, Missouri, Justin is a Ph.D. student in the Department of Ecology and Organismal Biology. He is conducting research questioning the conventional wisdom that bats should maximize hibernation when no insects are available to eat.

Justin's Fellowship is the latest accomplishment for Indiana State's Center for North American Bat Research and Conservation. Next month, the Center will host the Great Lakes Bat Festival which is expected to attract more than 2,000 people.

Co-sponsored by the Organization for Bat Conservation, the festival will feature talks, demonstrations and poster presentations about bats and related topics, the sale of books on bats and other wildlife, including the newly published "Bats of Indiana," displays of several species of live bats, an inflatable cave for exploring, demonstrations of bat netting, radio-tagging, echolocation and light tagging, among other activities. Congratulations to the Center for hosting this festival.

Expedition on Climate Change

This weekend, three Indiana State University Geology students and two of last year's graduates will receive hands-on experience in an oceanographic research expedition exploring issues related to global warming.

Leading the expedition as its chief scientist will be ISU Associate Professor of Geology Tony Rathburn. Researchers and students from six institutions are participating in the project which is funded by the National Science Foundation. The scientists will examine methane seeps 1,000 meters below sea level in Monterey Bay. One goal of the project is to provide the ability to more accurately assess past environmental and climate changes and utilize that knowledge for assessing the rate that modern climate is changing.

This important work has captured the attention of several environmental groups and elected officials interested in the global warming issue. Members of the California General Assembly, the Mayor of San Francisco and Congressional staff members are planning a news conference in conjunction with the research expedition prior to Sunday's launch.

The student's experiences as well as the research work will be captured by our own videographer, Tracy Ford, whose expenses are also being paid by the NSF. We hope to share some of this footage and hear from the students at a future meeting.

Cynthia Shepard Perry

Earlier this month, we were pleased to have former Ambassador and Distinguished Alumna Cynthia Shepard Perry return to campus to share her experiences with our students. Perry is now serving as the U.S. Executive Director of the African Development Bank, based in Tunis, Tunisia. She describes her current position as similar to being an Ambassador to 53 countries. The bank provides funding for schools, bridges and other projects aimed at combating poverty and helping African nations develop.

A key message she delivered to the students was about the need to become citizens of the world as the world's problems are interconnected and will require global solutions.

It is exceedingly gratifying to have outstanding alumni such as Ambassador Perry return to our campus and share these very worthwhile messages and experiences with our students.

Introductions

As my last item, I would like to introduce three key individuals who are new to our campus.

First, it is my pleasure to welcome John Beacon as our new Vice President for Enrollment Management, Communications and Marketing. John started his work last week and has already met with key leaders across campus. He hit the ground running and is cognizant of the fact that we expect him to continue to keep up the pace.

John brings a wealth of enrollment management experience to Indiana State and is actually joining our administrative staff for the second time. Early in his career, John worked as an Assistant Director of Admissions here at Indiana State while earning his Master's Degree. He comes to us from Western Michigan University where he served as Vice Provost of Enrollment Management. He also served as the Assistant Provost and Dean of Enrollment Management at the University of Maine and in admissions leadership roles at the University of Nebraska, Oklahoma State University, Eastern Illinois University and Illinois Valley Community College.

I would like to invite John to say a few words about himself and provide the Trustees with an update on the enrollment outlook for this fall.

Indiana State University has solicited proposals for a campus multi venue video display system. The system will be used in various campus areas including Hulman Center, Memorial Stadium, Hulman Memorial Student Union, and Tilson Auditorium. The price is estimated to be less than \$749,000.
