# Fundraising News

# 2015 Annual Report

- The ISU Foundation Annual Report is now live on our website. It can be accessed by clicking the appropriate homepage banner at indstatefoundation.org.
  - We worked with the Office of Communications and Marketing to develop the site. This is the third year for the partnership.
  - Some items to note in the report:
    - The endowment grew from FY14 to FY15. We ended FY15 with an endowment value of \$56,532,000.
    - Last fiscal year concluded with \$7,476,000 in philanthropic support raised for Indiana State University.
    - As of June 30, 2015 we have \$24,375,000 in planned gift commitments pledged to the University.
    - We did see a decline in donors from FY14 to FY15. This is in line with the national trend with other institutions who are experiencing a decline in total donors. However, this year, we are happy to report that through this point in the 2<sup>nd</sup> quarter we are seeing an increase in donors to the University.
    - We enhanced our donor honor roll feature that allows viewers to have an expanded view of our annual giving society groups.

# Fiscal Year 2016 Fundraising Numbers

- In the second quarter of fiscal year 2016, the Foundation has increased giving to The Fund for Indiana State.
  - As of Monday, December 7, 2015
    - The total dollars has increased, compared to this time last year
    - The number of total donors has increased by 123 donors
      - The number of President's Society level donors (\$1,000 or more) has also increased
      - Our donor retention rate has increased over last year by 25 percent
- As of Monday, December 7, overall fundraising stands at \$ \$1,427,850 from 3,504 donors.

- This is an increase of nearly 34% in the number of overall donors.
- This is an important figure because the national trend is showing a decline in the overall number of donors

# Calendar Year End Stewardship

- We have also worked with the student media group, Syc Creations, to develop our year-end thank you video. This will be sent to all donors who made a gift during the 2015 Calendar Year.
  - They also produced a video for our year-end solicitation video that will be sent to renewed and retained donors as well as non-donors.
- The Foundation has produced our second annual ornament in the President's Society Collection. This ornament showcases a former campus building "Old Main" in honor of the University's Sesquicentennial Anniversary.
  - I am pleased to provide our Trustees who are members of the President's Society with their ornament today.

# **Athletics Fundraising**

- To date, the Sycamore Athletic Fund has raised \$577,679 in support of Sycamore Athletics.
  - We have increased the total number of donors to athletics, compared to last fiscal year at this time.

# Alumni Club Activity —

- Basketball season has sparked the activities of the Alumni Association's alumni clubs. To date, there are 17 viewing events planned in our club areas. These are great opportunities for alumni, friends and fans to network and cheer on our Sycamore teams.

- The Alumni Association has achieved growth in the official alumni membership program, the Blue Card Club. To date there are currently 1,395 members.
  - Annual membership runs from July 1 June 30.
- Current club activity includes the holiday spirit mailing that provided ISU gift tags to members and the Blue Card Club Appreciation Nights is planned for the ISU Basketball double header on January 24. Members have the opportunity to watch the men's and women's games from the suite.

## **REPORT OF THE UNIVERSTY PRESIDENT (Dr. Bradley)**

(Dr. Bradley submitted the following report)

#### STUDENT GRIEVANCE POLICY

For several months, the University has been aware of the need for a university-wide student grievance policy and process to ensure consistency for all students.

I have approved the implementation of an interim policy which was developed following input from campus and the governance units.

The governance units have agreed to move quickly on the development and implementation of a more "permanent" policy with the goal of bringing the proposed policy to the board in February. I am also asking that the campus review options to provide support for students during the grievance process.

We are also working with the governance units to appoint a Student Grievance Committee as outlined in the interim policy.

This is an aggressive timeline for this important work. I deeply appreciate the assistance and cooperation displayed by the governance units, especially the Faculty Senate, in addressing this important issue.

#### CONSTRUCTION UPDATES

On the construction front, work continues on the renovation of Dede Plaza and Blumberg Hall. Progress also continues with the efforts to renovate and expand the Hulman Civic Center. You may have recently heard that the Vigo County Council unanimously supported a request from the County Commissioners for \$400,000 to go toward the costs of the project's design work. The Terre Haute Convention and Visitors' Bureau board also voted to pledge \$200,000 toward the design phase, and Mayor Duke Bennett has maintained his commitment to it as well. I am grateful to our local partners for taking this important next step which will give us a better understanding of the design and cost of the project.

The schematic design for the \$64 million renovation and expansion of the Health and Human Services Building has been approved, and the architects are now in the construction development phase. The plan is to be ready to seek state approval for the project in the spring and to be in a bid-ready position by early summer.

Diann McKee and Greg Goode will be going before the State Budget Committee next week to request final approval to move forward with the renovation of Cromwell Hall, the third of the Sycamore Towers to be renovated. Work on Blumberg Hall is progressing and should be completed by summer 2016. Work on Cromwell will begin as soon as the Spring semester concludes.

#### **CHAMPION AWARD**

Last week, Indiana State was recognized by the Indiana Commission for Higher Education as an inaugural recipient of the Champion Award for our efforts in assisting 21<sup>st</sup> Century Scholars meet their educational goals. I have asked Associate Vice President Joshua Powers to say a few words about this honor and introduce other individuals who share in this recognition.

[Comments from Dr. Powers]

Thank you, Josh and congratulations on this recognition.

#### DIVERSITY REPORT

Lastly, as discussed in our seminar earlier this afternoon, the University is actively working to address ways to create an environment of inclusive excellence for all on our campus. On your agenda today is the acceptance of the 2014-2015 report from the Diversity Council. As indicated during the seminar, there is interest in adjusting the composition of the Council to include representation from each affinity group. Work on drafting new handbook language will be completed in the coming weeks and shared with our governance units. It will then be brought to the board for approval. I would like to thank Elonda Ervin and the Council for their work.

#### STRATEGIC PLANNING

Earlier this afternoon, I gave my annual update on the strategic plan. The dashboards are important as a meaningful way to gauge progress. They do not, however, tell the whole story. Indiana State has had literally hundreds of faculty and staff working

collaboratively on all aspects of the strategic plan. It is only through this type of involvement that such significant strides can be made. I appreciate everyone who has worked toward advancing these goals. There is no doubt that the plan has been aggressive but its success has been essential to improving our students' experiences, funding new initiatives and providing compensation increases for our faculty and staff.

This somewhat hectic pace will need to continue. In today's world, it is critical that we continue to adapt in order to thrive in the future. I deeply appreciate Provost Mike Licari's leadership in driving the development of the next strategic plan. I would ask that our faculty, staff, students, alumni and community take advantage of the many opportunities to get involved in its development. This is a great opportunity to shape our institution's near future – something that can impact all of us as well as future members of the ISU family.

# REPORT OF THE BOARD CHAIRPERSON (Mr. Campbell)

(Mr. Campbell made the following comments)

We had three excellent seminars today, one on student success, one on diversity and inclusion, and the last one on our strategic plan. So, President Bradley thank you for you openness and for having an open dialogue.

This next strategic plan is also just as important to give us a pathway to the future. Tomorrow is Winter Commencement and a lot of successful students will cross the stage, and we need to be very thankful that they are graduating. I am very happy for them as it is always fun to see graduating students and their families at commencement time.

Personally, I would like to wish everyone Happy Holidays, however you may celebrate. The semester is over. We can now rest for a few weeks and enjoy our successes. I would hope that it also is a time that we can look for opportunities that we have for next year and all look forward to good 2016.

# **5b Finance Committee Report**

# 5b1 ISU Housing and Dining Rates for 2016-17

#### On Campus Housing

As the University continues to strategically invest in improving student housing, rates are reviewed annually to ensure student housing remains affordable and that residence hall rooms are categorized with the appropriate room type rate. For 2016-17, room types have been modified to more accurately reflect room amenity offerings based on the recent renovations of the majority of the residence halls. Room types for 2016-17 will include Economy, Standard, Premium and Premium Plus rooms. The proposed rate increase for a Standard residence hall room and a Standard meal plan represents a 2.9 percent increase for 2016-17.

Rhoads Hall, the only residence hall during 2016-17 without air conditioning, is categorized as Economy and is proposed to have a minimal annual increase of \$61.20. Hines Hall and Jones Hall, renovated over 15 years ago, are proposed to move from a Premium room rate to the Standard room rate in 2016-17 resulting in a reduction to the student room and board rate of \$234.60 per year. The Premium and Premium Plus room types will include rooms in residence halls more recently upgraded and offer students more amenities than a Standard room. A Premium room is an additional \$1,020 per year, and a Premium Plus room is an additional \$1,530 per year above the Standard room rate.

The Non-Flex meal plan rates, first offered in 2013-14, are included with the housing rate options. The Non-Flex meal plan offers a reduced rate from the Standard meal plan. Students utilizing this reduced rate plan do not have the flexibility to roll meal plan credits from week to week or have the availability of commons cash.

The recommended 2016-17 rates for on campus housing are listed below and include additional room accommodation options and meal plan options. The 2015-16 housing and dining rates are included with this item for comparison purposes.

#### 500 Wabash & University Apartments

In the 2015 Fall semester, the University began offering a housing option located at 500 Wabash Avenue providing students with furnished suites, kitchens, and high end amenities. Students living in these suites are afforded the same resources as students living on campus including all-inclusive utilities, ISU networked internet and cable, safety and security features, and access to professional live-in staff.

In an effort to create student friendly housing packages for off campus housing, the University offers both full year and academic year contracts at 500 Wabash and University Apartments. The rates for 500 Wabash and the furnished University Apartments units are a per student rate billed by the semester. The unfurnished family units at University Apartments are a per unit rate.

The proposed rates for student rooms at 500 Wabash & University Apartments represent a 2.9% increase. An optional meal plan will be offered to students living at University Apartments and 500 Wabash.

#### Residence Hall Damage Charge Calculation

The cost of student room and community damages caused by abuse or misuse of Residential Life housing facilities or equipment will be charged to the student account at the current replacement value of the damaged item plus the hourly labor rate necessary to restore the facility/equipment to its original condition. Students requesting a temporary loaner key will be charged \$5 per incident. After a student requests a loaner key three times in a semester or when a student does not return the loaner key within the designated time period, the student will be charged the cost to recore the room. This recore is completed in order to ensure a safe living environment for all community members.

#### Room & Board Refund Schedule

Beginning in the Fall 2016, a new refund schedule is being recommended for students who are either released from their housing contract or withdraw from the university. The housing portion and the base meal plan portion will follow the schedule below. Student meal plan credits will be refunded at the current conversion rate (currently \$.20 per credit). Unused commons cash will be refunded to the student in full.

# 5b2 University Health Benefits Plan For 2016

<u>Employee Medical Coverage:</u> It is recommended the University's self-insured medical plan continue to be administered by CIGNA. Retirees not yet age 65 are retained on this plan until reaching Medicare eligibility at age 65. There are no changes recommended in the medical plan design for 2016.

<u>Prescription Drug Coverage</u>: It is recommended the University continue to utilize the State of Indiana Aggregate Prescription Purchasing Program (IAPPP) administered by Express Scripts. For 2016, it is recommended the University move from the Basic Formulary (list of preferred medications) to a National Formulary. This change is estimated to reduce costs by \$170,000 per year.

<u>Dental Coverage</u>: It is recommended the University's dental coverage continue to be administered by Delta Dental of Indiana with coverage enhancements as follows:

- Adding implant coverage
- Adding posterior composite resins

• Adding Evidence Based Dentistry for certain diagnosis codes, i.e., periodontal disease with diabetes, pregnancy, renal failure/dialysis, chemo therapy, transplants, radiation and those at risk for endocarditis.

• \$1,200 annual maximum remains in effect

Employee Coverage Rates: For 2016, rates are once again based on wellness participation with a voluntary subsidy. Participation of employees with no spouse/partner on the coverage provides a \$30 per month rate discount during 2016. Employees and spouses covered on the plan who both participate will be provided a \$50 per month rate discount. There is also a \$50 per month tobacco surcharge added to the rate for employees and/or spouses who are tobacco users. Employees /spouses may agree to participate in a tobacco cessation program to avoid the surcharge for up to two years only. Employees with household income less than 200 percent of the 2015 Federal Poverty Guidelines may apply for a subsidized rate that is approximately 20 percent less than normal rates. Additionally, a shift in the employee share for Employee/Spouse and Employee/Dependent plans has been included for 2016 as a part of a long-term strategy designed to increase the employee share to approximately one-third of the total premium cost for these plans.

Claims experience and medical inflation factors continue to be considered in the rate increase process. ISU's claims cost over the past year has been less than forecasted medical/Rx trends resulting an overall projected rate increase for 2016 of 4.9 percent.

For active employees, the following premium rates are recommended, effective January 1, 2016. The rates as shown below are inclusive of medical, prescription drug, and dental coverage. Health coverage rates for 2015 are also included for comparative purposes.

<u>Retirees Over Age 65</u>: It is recommended that the fully-insured plan combined with a self-insured dental plan for retirees over age 65, meeting certain eligibility criteria, be continued with AmWINS (formerly NEBCO) with no change in medical or prescription drug coverage. An increase in the fully insured retiree coverage and Part D prescription drug program rates is recommended for 2016. Eligible retirees participating in Option 1 will have an increase of \$7.00 per month per person. Option 2 includes an enhanced prescription drug coverage program. Claims for prescription drugs under Option 2 for the past year were more than 40 percent higher than the previous year resulting in a total increase of \$77.01 per month per person. Retirees utilizing Option 2 may change to Option 1 for 2016 if desired.

<u>Specific Stop Loss</u>: The \$250,000 individual stop loss deductible policy is recommended to continue with a new vendor HCC effective January 1, 2016. HCC has requested a premium increase of 3.1 percent over the premium of the previous vendor (Symetra) who was requesting a 125.7 percent rate increase.

# 5d Modification to Faculty Constitution Section 245.3

- The Faculty Senate voted to modify the following sections of the faculty constitution. Both modifications were placed before the faculty for a vote and it surpassed the necessary 40% vote participation and was approved by the faculty.
- The rationale for the change to 245.3.1 is to recognize the existence of the University College, and clarify that it does not have separate representation on the Faculty Senate, since it currently does not have an independent faculty, much as is true for the College of Graduate and Professional Studies.
- The rationale for change to 245.3.5 is to bring the handbook in line with current practice. The incoming Executive Committee and Officers need to be involved in planning for the coming year rather than the outgoing officers.

245.3 Structure of the University Faculty Senate

## 245.3.1 Membership.

**245.3.1.1 Faculty Representatives.** There shall be 34 elected faculty members. They shall be apportioned among the colleges of the University in this fashion: the total number of voting faculty in the University shall be divided by 34; this number, rounded off to the next higher whole number, shall be the "election unit." Each college shall have as many representatives as it has complete election units of voting faculty provided that every such college is to have at least one (1) representative. The remaining seats, up to the total of 34, shall be apportioned to the colleges with the largest fractional remainders of voting faculty, lot being resorted to if equal fractional remainders make this necessary. This calculation shall be made before each annual election.

**245.3.1.1.1 Transition Period.** In the transition from 40 to 34 members, there shall be an intermediate year with 37 members and 37 as the unit of election.

**245.3.1.1.2 University Library.** In this Constitution the word "college" shall be understood to include the University Library as a coordinate academic subdivision.

**245.3.1.1.3 College of Graduate and Professional Studies.** The College of Graduate and Professional Studies is not a coordinate academic subdivision in this sense and is not entitled to separate representation in the University Faculty Senate.

#### **Proposed Language:**

245.3 Structure of the University Faculty Senate

#### 245.3.1 Membership.

**245.3.1.1 Faculty Representatives.** There shall be 34 elected faculty members. They shall be apportioned among the colleges of the University in this fashion: the total number of voting faculty in the University shall be divided by 34; this number, rounded off to the next higher whole number, shall be the "election unit." Each college shall have as many representatives as it has complete election units of voting faculty provided that every such college is to have at least one (1) representative. The remaining seats, up to the total of 34, shall be apportioned to the colleges with the largest fractional remainders of voting faculty, lot being resorted to if equal fractional remainders make this necessary. This calculation shall be made before each annual election.

**245.3.1.1.1 Transition Period.** In the transition from 40 to 34 members, there shall be an intermediate year with 37 members and 37 as the unit of election.

**245.3.1.1.2 University Library.** In this Constitution the word "college" shall be understood to include the University Library as a coordinate academic subdivision.

**245.3.1.1.3 College of Graduate and Professional Studies.** The College of Graduate and Professional Studies is not a coordinate academic subdivision in this sense and is not entitled to separate representation in the University Faculty Senate.

245.3.1.1.4. University College. The University College is not a coordinate academic subdivision in this sense and is not entitled to separate representation in the University Faculty Senate.

245.3.5 The Executive Committee of the University Faculty Senate.

**245.3.5.4 Term of Service.** The Executive Committee of the Faculty Senate shall serve from August 10 of the upcoming academic year to August 9 of the following year.

245.3.5 The Executive Committee of the University Faculty Senate.

245.3.5.4 Term of Service. The Executive Committee of the Faculty Senate shall serve from June 1 of the upcoming academic year to May 31 of the following year.

# 5e Modifications to the Bylaws of the Faculty Constitution Section 246.15

In October 2015, the Faculty Senate voted to add section 246.15 to the University Handbook. This section codifies the selection, duties, and compensation of the Temporary Faculty Advocate to the Faculty Senate.

Proposed language:

**246.15 Temporary Faculty Advocate** The Temporary Faculty Advocate (TFA) is a part-time or full-time Lecturer selected to serve a one-year term which begins on the Monday prior to the September Faculty Senate meeting.

**246.15.1 Selection** The TFA is selected by the Provost from a list of no more than three (3) nominees provided by the Executive Committee of the Faculty Senate.

**246.15.1.1 Nomination Call** The Chairperson of the Faculty Senate will send a call for nominations to all known temporary faculty not before the first day of classes and not later than the last day to add classes for a Fall term. Nominations will be taken for five (5) working days.

**246.15.1.2 Statements of Interest** Nominees will be asked to provide the Executive Committee a Statement of Interest within five (5) working days.

**246.15.1.3 Survey of Support** An electronic survey of temporary faculty will be conducted among the temporary faculty with five (5) working days to respond so as to gauge support for each candidate. That survey will include all statements of interest.

**246.15.1.4 Role of the Officers of the Senate** The officers may, using the statements of interest and the survey of support, conduct interviews with some or all of the candidates.

**246.15.1.5 Executive Committee Role** With the results of the survey and interviews, the Executive Committee will choose no more than three (3) nominees for consideration by the Provost. Preference should be given to temporary faculty where there is a reasonable expectation that the faculty member will have a Spring teaching appointment.

**246.15.2 Duties** The TFA is responsible for delivering a report and participating in meetings of the Senate as well as meetings of the Faculty Affairs Committee. The TFA is the point-person for temporary faculty concerns and is expected to make contact information available to the temporary faculty.

**246.15.3 Compensation** The TFA will be compensated in an amount equal to the base temporary faculty compensation for one-credit hour of teaching. Compensation will be paid on 11/1, 3/1, and 6/1.

# 5h Modification of use of Program Fees for Department of Applied Medicine and Rehabilitation

The Board of Trustees approved the assessment of graduate degree program specific fees for the Master of Physician Assistant Studies and Doctor of Physical Therapy programs on May 7, 2010. In addition, approval was granted for the assessment of graduate degree program specific fees for the Master of Occupational Therapy (MSOT) Program on February 17, 2012. Program fees were to be used for consumable items, capital expense lab equipment, adjunct clinical faculty, faculty research, and faculty travel. Fees are \$1,000 per semester and are tied to specific courses within each respective degree program.

Upon review it has been determined the approved use of the program specific fees assessed students in these programs be modified to include the following:

- Affiliate Faculty
- Cadavers
- Capital Equipment (i.e., instructional equipment and supplies)
- Clinical Education Supplies
- Consultant Fees (i.e., program development, faculty recruitment)
- Consumable Items
- Electronic Media for Students (i.e., profession-based preparations)
- Program Development (i.e., residency programs, specialization tracks)
- Safety and Calibration Inspections
- Student Development (i.e., conference travel, research presentations, exam preparations, awards)
- Uniforms (i.e., lab coats, scrubs, professional uniform shirts, name tags)

# 5j Conferral of Honorary Degree

A native of Evansville, Indiana, Gayle (Karch) Cook co-founded a medical instrument business with her husband, Bill, in 1963 in their small apartment in Bloomington, Indiana. Fifty-two years later, Cook companies are worldwide leaders in the manufacture and sale of medical devices.

In addition to this entrepreneurial prowess, the Cook family is known for its extensive work in historic preservation and restoration which has been recognized with numerous accolades. The family's biggest restoration project was the French Lick/West Baden resort which won the National Trust Award in 2007. In total, they have restored around 70 buildings throughout Indiana and Illinois.

At Indiana State, Gayle has been generous in sharing her time, expertise and financial resources including delivering a lecture on "The Magnificence of Domes" four years ago. She provided valuable advice on the restoration of Normal Hall and was instrumental in connecting the University to expert artisans who worked on the project. Through the Gayle and Bill Cook Foundation, Gayle and her son, Carl, have provided significant support to Indiana State's Sesquicentennial Capital Improvement Fund which helped expand the Normal Hall restoration beyond the state-funded project and will also support improvements to other historic properties on ISU's campus.

In recognition of her extensive historic preservation work, Gayle (Karch) Cook is recommended for conferral of an honorary doctor of humane letters during the December 12, 2015 commencement ceremony.

# 5k 2014-15 Report of the President's Council on Diversity

Public Law 167, an amendment to the Indiana Code in 2007, required the formation of a diversity committee at each public higher education institution in Indiana. The committee is charged with reviewing and recommending faculty employment policies concerning diversity issues, reviewing faculty and administration personnel complaints concerning diversity issues, making recommendations to promote and maintain cultural diversity among faculty members, and making recommendations to promote recruitment and retention of minority students. The law requires the committee to create an annual report of its findings, conclusions, and recommendations and provide it to the Board of Trustees.



The charts below show the Fund's performance by tier over various time periods versus the appropriate benchmark and peer group.












#### Revenues

#### Student Tuition

Student tuition is above the 2014 amount by \$3,403,911 inclusive of a 1.9 percent increase in tuition for 2015-16 and Fall 2015 enrollment growth.

## Other Fees and Charges

Other Fees and Charges increased \$77,723 from the prior year. Included are deferment fees, collection fees, and undergraduate application fees related to increased enrollment and the application pool of prospective students.

## Other Income

Other Income is ahead of last year's total by \$44,016 as an additional \$157,500 of utility reimbursement from Residential Life has been recorded. In addition, there is a timing difference in the IU Medical School reimbursements of \$110,000 compared to September 30, 2014.

## Reimbursements and Income Reappropriated from Other Sources

Reimbursements and Income Reappropriated from Other Sources reflects an increase of \$1,296,683 over the prior year. Included in the increase is \$700,000 of one-time funds appropriated for additional University Marketing activities as well as \$500,000 related to the upgrade of IT fiber throughout campus.

## Expenses

## **Compensation**

Compensation expense is above last year's amount by \$1,212,340 as instructional salaries and administrative salaries are up \$787,389 and \$165,630, respectively. Fringe benefits reflect an increase in medical expense for active employees offset by an increase from 50 percent to 75 percent reimbursement of retiree medical expenses from the VEBA trust.

## Departmental Expenses

Departmental Expenses includes an increase of \$1,712,309 of Supplies and Related Expenses. This is a result of a \$908,887 difference in the timing of purchase orders related to advertising costs, an increase of \$183,566 of office supplies, and an additional \$160,000 of travel expenses. Repairs and Maintenance reflects an increase of \$989,409 over the prior year. The majority of this amount is a result of expenses related to upgrading IT fiber in various campus buildings.

#### Equipment and Other Capital

It is anticipated budgeted equipment and other capital line-items will be expended later in the 2015-16 fiscal year as early spring/summer 2016 projects are bid.

<u>Utilities and Related Expenses</u> Utilities and Related Expenses shows a reduction of \$2,221,684 reflecting a decrease in natural gas costs.

#### Student Scholarship and Fee Remissions

Student Scholarship and Fee Remissions increase of \$994,144 reflects growth in enrollment.
