MINUTES INDIANA STATE UNIVERSITY BOARD OF TRUSTEES

APRIL 23, 2004

The Indiana State University Board of Trustees met in regular session at 9:00 a.m. on Friday, April 23, 2004 in the State Room, Tirey Hall.

Trustees Present: Mr. Alley, Mr. Bonds, Mr. Carpenter, Mr. Fleetwood, Mrs. House, Ms. Robertson, Mr. Shagley, Mr. Smith and Dr. Zietlow.

President Benjamin, Vice Presidents Bouse, Floyd, Ramey and Schafer and Interim Vice President Maynard were present. Also attending were Ms. Melony Sacopulos, General University Counsel, Dr. Harriet Hudson, Chairperson, University Faculty Senate, Ms. Trina Langley, Chairperson, Support Staff Council and Mr. Douglas Huntsinger representing the Student Government Association.

There being a quorum present, Mrs. House called the meeting to order at 9:10 a.m.

SECTION I

A. APPROVAL OF THE MINUTES (Mrs. House)

On a motion by Dr. Zietlow, seconded by Mr. Bonds, the minutes of the February 27, 2004 meeting were approved as presented.

B. <u>DATES OF NEXT MEETING</u> (Mrs. House)

The dates for the next meeting are June 17-18. The June meeting will be held in Indianapolis.

Commencement is on Saturday, May 8.

C. <u>REPORT OF THE BOARD PRESIDENT</u> (Mrs. House)

Mrs. House appointed the Nominating Committee for the election of officers for 2004-05. Members of the nominating committee are Charlotte Zietlow, Chairperson, George Fleetwood and Jessica Robertson.

In accordance with a request by Governor Kernan, the Trustees held an open forum on student tuition for the 2004-05 academic year on Thursday afternoon in the State Room. Mrs. House thanked Vice President Floyd and Diann McKee for their presentation and for the remarks by the Student Government Association.

Mrs. House noted she recently attended the retirement tea for faculty and staff. She thanked and acknowledged the years of service of the retiring faculty and staff.

On Thursday evening the Trustees attended the faculty recognition banquet. Mrs. House felt the design of the program was tastefully done. She was pleased to see Mr. Boulet, President of the ISU Foundation, in attendance.

Mrs. House asked Dr. Zietlow to report on her April trip to Morocco with the group from ISU.

Dr. Zietlow commented that ISU is involved in a top level training program of higher education administrators in Morocco as the result of a USAID contract between ISU and Hassan II-Mohammedia University in Morocco. Hassan II-Mohammedia is the lead Moroccan university involved, but the work includes representatives from most of the 14 public universities in that country. The purpose is to have the ISU team train the Moroccan Fellows in the transition from a basically French system of higher education to one resembling an American system. This is the result of a reform initiative by King Mohammed VI to bring the entire country into the twenty first century, to make the educational system more accessible, more accountable, and more responsive to the social, economic and political needs of the country.

Last summer 17 Fellows spent three weeks in the United States, mainly at ISU in Terre Haute. Dr. Zietlow spoke with them at that time about the very foreign concept of Trustees, and they invited her to follow up this spring so she went and spent a full day in discussions about the role of Trustees.

Morocco is an Islamic country but it has Berber origins, and a long history of very peaceful relations with its Jewish citizens. Nearly 50 per cent of the University students are women; 75 per cent of the students at the Hassan II-Casablanca Medical School are women! Many of the Moroccans wear the long robes called djellabahs (with peaked hoods for the men and covering headscarves for the women). A very large number also wear western clothes. It is a country of contrasts. The country has few natural resources, but is a major agricultural and tourism center, and values, tolerance, education and the skills of its craftspeople. The present king is committed to economic development and sees education, health care and the eradication of poverty as central to this goal.

Dr. Zietlow felt that the Fellows involved in the program, led by a formidable and very engaging woman, Rahma Bourquia, the President of Hassan II-Mohammedia, are well-educated, intelligent, focused, committed to change in a part of the world that values tradition and values the fine points of life. They are

working very hard to make the tremendous shifts needed and are sophisticated and open-minded.

The main thrust of the program with Hassan II is leadership development for higher education officials, but ISU is also working with the Moroccan Soccer Federation to train the trainers in their soccer programs, and the ISU sports management program will bring 12-14 soccer professionals to Terre Haute this summer for a leadership training program which will be followed by a site visit by ISU faculty to build a training program there. ISU has also proposed a pilot leadership program in the delivery of rural health care between the Midwest Rural Health Clinic at the Landsbaum Center and the Hassan-II Casablanca School of Medicine and possibly the medical school at Marrakech.

Dr. Zietlow commended El-Houcin Chaqra, a native of Morocco and member of the ISU administration; Gaston Fernandez, Director of the International Center Programs, and President Benjamin for their support of this initiative.

D. REPORT OF THE UNIVERSITY PRESIDENT (Dr. Benjamin)

Student Financial Aid

A professional standards team from NASFAA was on campus for an operations review. While the report to be received in a couple of weeks will have some recommendations. Some very encouraging things about progress in this important area were noted.

Controller's Office

Controller and Assistant Treasurer Bob Sackett has left ISU for a medical college in Augusta, Georgia. His responsibilities are being covered by Assistant Controllers Dom Nepote, Bursar Operations, and Jeff Jacso, Director of Financial Accounting. These two individuals have long and productive tenure with ISU's financial operations.

Compensation Study Update

In compliance with the Board's request at its last meeting, we have briefed the campus community on the full process and current status of the compensation study. The Compensation Study Committee has been meeting frequently and will be ready to have a report for the Trustees at the June meeting.

The monthly Sycamore Showcase at Noon forum is designed to foster University-community engagement. Through the Showcase presentations, educators and citizens can join together to address common concerns and emerging needs. Dr. Benjamin expressed appreciation to Mrs. Benjamin for proposing the idea and to Allen Varner who is coordinating the monthly events.

E. REPORT OF THE UNVERSITY FACULTY SENATE CHAIRPERSON (Dr. Hudson)

Dr. Hudson acknowledged the attendance of the trustees at the Faculty Recognition Dinner. She thanked those responsible for making it possible to recognize faculty accomplishments, and she welcomed the opportunity to honor the service of the Faculty Senators and committee members.

The Senate has been busy as it brought forward the results of a year of committee work to meet the deadline of its final meeting. In March the Senate passed the special purpose faculty guidelines and the code of student conduct. The special purpose faculty document provides for fairer hiring practices and compensation and guidelines for an appropriate mix of tenured and non-tenured faculty. The Student Affairs Committee has made recommendations for a student grievance policy which should be formalized next year. It will complement procedures in the student code of conduct. The Senate also endorsed the reorganization/reporting of the Center for Public Service and Community Engagement and the reorganization of the Library.

Next week the Senate will act on a revision of the sabbatical leaves procedure, the academic calendar for 2006-07, revision of the University Handbook section on department chairpersons, a proposal for the extension of faculty benefits, and procedures to implement the faculty scholarship.

Next year's University Faculty Senate and Executive Committee have been elected. Four new members are coming on the Executive Committee, with five members continuing. The officers were re-elected: Dr. Steve Lamb, Sister Mary Alma Anderson, and Dr. Hudson.

Currently Senate committees are responding to draft reports of the President's strategic planning committees on community engagement, eminent programs, and experiential learning. The work of the latter is particularly within the Senate's purview which includes courses of study, facilitation of research and teaching, and the educational philosophy of the University and the relation of existing and future curricula, and educational policies to that philosophy, to quote the Faculty Constitution. Concerns have been raised, not about experiential learning itself, but about the manner of its implementation as a strategic objective. Faculty and Senate responses have been sought and are being incorporated.

Dr. Hudson discussed the University Bookstore contract with Barnes and Noble. The terms of this contract and the level of service provided to faculty and students have been the subject of much discussion this year, and input was received.

Dr. Hudson thanked Megan McManama for her support of the University's requested tuition increase. Faculty recognize the need to keep tuition low so students can afford to come here, and many of them have put children through college so they know the impact of increases. If the University is to attract and retain excellent faculty, adequately compensate non-tenured faculty, and continue to advance in the present state budget climate, some increase is necessary. It is gratifying to know that students understand this difficult issue and are willing to make the sacrifice to maintain the institution.

F. REPORT OF THE SUPPORT STAFF COUNCIL CHAIRPERSON (Ms. Langley)

Ms. Langley was honored to welcome retiring ISU employees at the annual retirement tea. This is the first year retiring support staff were included in the event.

The Support Staff scholarship provides financial assistance for ISU Support Staff who enroll in classes while employed at ISU. The Scholarship Committee was charged earlier this year to develop specific criteria for selecting awardees and to review the scholarship agreement. The process has initiated a passionate interest among Council representatives, which in turn slowed progress on the revision of the Council Bylaws. The Committee has recently made substantial progress, and we expect that agreement on the scholarship agreement and selection criteria will be completed in mid-May and presented at the May Council meeting.

There are several issues Council presented this year for action that have not come to a resolution. Ms. Langley remains hopeful that the Council's requests for a technology fee reduction, the retirement incentives, and changes to the process and paperwork for support staff tuition waivers will be addressed and approved yet this year.

The annual meeting of support staff will be held in the Mills Dining Hall on May 27. The meeting provides the only formal opportunity during the year for all support staff at ISU to gather for an update from Council representatives and for fellowship.

G. REPORT OF THE STUDENT GOVERNMENT ASSOCIATION PRESIDENT (Mr. Huntsinger)

Doug Huntsinger reported for Megan who was unable to attend. He introduced Hobart Scales, the new Vice President of the Student Government Association.

SGA has been involved in discussions of a proposed new recreation center and the possibility of a student fee through a referendum to be voted on by the students. A study group has been formed to determine student interest.

Work is progressing on changing procedures for choosing student justices, and it is hoped the new process will help assure the selection of student justices who are interested in serving.

The petition circulated regarding textbook costs has been sent to Senator Lugar's office. After contact with the Federal Trade Commission, his office will report back the findings.

Doug thanked Dr. Hudson for all her help this year and also the Support Staff Council.

H. <u>CANDIDATES FOR DEGREES</u> (Dr. Maynard)

Candidates for graduate and undergraduate degrees to be conferred on May 8, 2004, are presented in Exhibit A.

<u>Recommendation:</u> Approval of the candidates for degrees to be conferred on May 8, 2004, subject to completion of the requirements.

On a motion by Mr. Smith, seconded by Mr. Shagley, the recommendation was approved.

I. EXTERNAL AUDITS POLICY (Dr. Benjamin)

Internal Audit Department has the responsibility for coordinating the visits and/or inquiries of all compliance and financial outside auditors, e.g., federal, state audit agencies, and public accounting firms. As part of the audit coordination process, Internal Audit Department serves as a liaison between university offices and external auditors.

All initial contacts with external auditors are to be arranged through the Internal Audit Department. If any University personnel are contacted directly by external auditors, they are to notify the Internal Audit Department immediately. The entrance conference is the initial meeting to discuss the scope of an external audit.

The exit conference is the final meeting to discuss the recommendations. The Internal Audit Department will coordinate all entrance and exit conferences with the appropriate University officials and with the external auditors. The Internal Audit Department may assign a designee to represent the Internal Audit Department during the review process.

The Internal Audit Department is to receive copies of all external audit reports within two weeks of receipt of the official reports. It is the responsibility of all University officials to assure all external audit groups have made the appropriate contact with the Internal Audit Department and that the Internal Audit Department receives a copy of all audit reports. University officials responsible for areas undergoing audits must contact the Internal Audit Department if any issues arise concerning the audit or possible findings.

Recommendation: Approval of the external audits policy effective May 1, 2004.

On a motion by Dr. Zietlow, seconded by Mr. Shagley, the recommendation was approved.

J. <u>STUDENT ACADEMIC SEMESTER FEES FOR 2004-05</u> (Mr. Floyd)

<u>Recommendation</u>: Approval of the academic student fee schedule beginning with Fall 2004 through Summer II 2005, as presented in Exhibit H.

On a motion by Mr. Fleetwood, seconded by Dr. Zietlow, the recommendation was approved.

K. <u>ACADEMIC LABORATORY/COURSE SPECIFIC FEES</u> (Mr. Floyd)

<u>Recommendation</u>: Approval of the proposed changes in academic laboratory/course specific fees effective Fall 2004 as presented in Exhibit I.

On a motion by Mr. Shagley, seconded by Mr. Carpenter, the recommendation was approved.

L. <u>BOOKSTORE CONTRACT EXTENSION</u> (Dr. Ramey)

A committee of students, faculty, and staff met in February 2004 to consider whether to renew or re-bid the existing contract between Barnes and Noble Bookseller Inc. and Indiana State University. The existing contract, signed in June of 2000, provides the potential for two four-year renewal (rollover) periods.

The committee recommended that ISU renew the contract with Barnes and Noble. In addition to the existing contract terms, Barnes and Noble agreed to pay Indiana

State University an additional \$60,000 over the life of the four-year extension. These funds will be used to enhance the availability of used textbooks, and to support ISU students with other marketing and promotion programs.

Recommendation: Approval of the letter of agreement submitted as Exhibit B to rollover the existing bookstore contract for a period from July 1, 2004 through June 30, 2008.

On a motion by Dr. Zietlow, seconded by Mr. Fleetwood, the recommendation was approved.

M. PROPOSED REVISIONS TO THE CODE OF STUDENT CONDUCT AND RIGHTS OF STUDENTS (Dr. Ramey)

A Task Force was appointed by the Vice President for Student Affairs to review the many aspects of the student conduct system including the Code of Student Conduct. The task force was asked to determine if the regulations in the Code are pertinent to the present University environment and if the regulations are clear and concise. Representatives from all segments of the University community were asked to participate in this effort.

The regulations of the present Code were developed and approved by the Board of Trustees during the late 1960's. Minor adjustments were made to the regulations since that time. The Task Force concluded that the regulations were not pertinent to the present University and that the regulations were not clear and concise.

The Task Force studied the codes of numerous other institutions including all the four-year public institutions in Indiana as well as a group of peer institutions. The Task Force also reviewed model codes developed by experts in the field. The two models which served as a basis for the proposed revisions are "A Model Code of Student Conduct; Applying the Power of Association on Campus" (Gary Pavela, Synthesis: Law & Policy in Higher Education, V11 #4, Spring 2000), and "Harnessing the Spirit of Insubordination: A Model Code for Student Discipline", (Edward N. Stoner II, 17 J.C.U.L. 89, 1990).

The Task Force recommends that Section 2.01 of the present code be replaced by the proposed regulations. The Task Force also recommends that several other sections of the present Code be abolished. Specifically, the Task Force proposes to rescind the following regulations:

 2.02 (Failure to Abide by the Policies Guaranteeing the Right of Expressions of Students),

 2.03 (Adjudication of Violations of Policies Guaranteeing the Right of Expression of Students), SECTION I PAGE TEN

- 2.04 (Failure to Comply with the Policies Regarding the use of university Buildings and Facilities by University Organizations and Groups,
- 3.02 (Failure to Comply with the All-University Social Policy),
- 3.04 (Failure to Comply with the Motor Vehicle Policy),
- 3.05 (Failure to Comply with the Provisions of the Outside Speakers Policy,
- 3.06 (Failure to Comply with the Procedures for Implementation of the Outside Speakers Policy).

These sections are no longer relevant or have been rendered redundant by sections of the new Code.

University Standards

University Standards was developed in response to a number of changes and new responsibilities faced by the University. The end of on-sight registration required that the Code and other policy documents be mailed to students. This, coupled with federal mandates to provide students with certain information (The Clery Act for example), necessitated the development of a publication that could be mailed at a reasonable cost.

During the last few years, federal regulations have no longer required that this type of information be mailed. The availability of this information on a web site has been deemed acceptable. This will allow the university to drastically reduce the content (and the cost) of printing and distributing University Standards. To this end, the Task Force has identified a number of policy documents that should be prominently situated within the University web site. Those documents include:

- The full text of the Code of Student Conduct (Procedures)
- The full text of the Indiana Chapters that empower the Board of Trustees
- Indiana Hazing Statute
- The ISU Motor Vehicle Policy
- The policy on Building and Facility Usage
- The Residence Hall Handbook
- The Student Handbook
- Sexual Harassment Prevention Policy
- The Policy and Implementation of the Family Educational Rights and Privacy Act (FERPA)
- Computing Policies and Procedures
- The Drug Free Schools and Communities Act
- The Smoking Policy

The revised Code will contain an index with links to these policies and documents.

Recommendation: Approval of the revisions to the Code of Student Conduct and Rights of Students as shown above effective July 1, 2004. The entire document is presented in Exhibit C.

On a motion by Mr. Shagley, seconded by Mr. Carpenter, the recommendation was approved.

N. <u>STUDENT HEALTH CENTER PRICING POLICY (Dr. Ramey)</u>

With the costs of medical services increasing at a rate of 15-20% per year, the Indiana State University Student Health Center seeks to establish an approved pricing policy that will allow a low cost, market sensitive, pricing structure that is advantageous to students, but flexible enough so that the Student Health Center can continue to operate on a break-even basis. The Center does not currently charge students for office visits. However, drugs, supplies, x-rays, medical procedures and laboratory tests are charged at prices that attempt to recover costs incurred.

It is recommended that drugs, supplies, x-rays, medical procedures and laboratory tests be priced in the Student Health Center at the actual cost of the item plus overhead. Overhead will allow for the cost to purchase, track and dispense medications as well as for a portion of the general operating cost of the Health Center. All services and products will be priced, where applicable, at ten to thirty percent (10%-30%) below manufacturer's suggest retail prices. Some items may be priced lower to insure student availability.

<u>Recommendation</u>: Approval of the Proposed Pricing Policy effective July 1, 2004 as outlined above.

On a motion by Dr. Zietlow, seconded by Mr. Shagley, the recommendation was approved.

O. <u>INVOLUNTARY MEDICAL WITHDRAWAL POLICY</u> (Dr. Ramey)

Student Affairs has developed a policy to address situations in which students pose a threat to themselves or others, or exhibit medically related behaviors that limit their ability to meet student responsibilities, academic and otherwise.

<u>Recommendation</u>: Approval of the Involuntary Medical Withdrawal Policy as presented in Exhibit D effective July 1, 2004.

T. PROMOTION/TENURE SPECIAL NEEDS (PROBATIONARY FACULTY) (Dr. Maynard)

Additional Language to University Handbook, Section III-3 – Criteria for Reappointment, Promotion, and Tenure

The Faculty Senate and the University recommend that our policy on tenure be revised to support the special needs of probationary faculty who have unique responsibilities related to the birth or adoption of a child, special health needs of family or partners, etc. It is recommended that the paragraph be inserted in the University Handbook.

Insert New Paragraph on page III-3, column 2, between current paragraph 2 and 3:

Candidates may elect to extend the tenure probationary period for a maximum of two years in the following circumstances: 1) They are the primary or co-equal caregiver of a newborn or newly adopted child (one year per child)). 2) They are

the primary or coequal caregiver of a seriously ill spouse, partner, or other immediate family member (defined as child, parent, or other family member).

Medical certification from the ill person's health care provider shall be presented within fifteen calendar days after the extension is requested. Additional medical opinion may be requested at the University's expense. The candidate shall consult with his/her department chairperson to receive support of the extension. The decision to extend the tenure period will be reported to the Dean and the Provost and Vice President for Academic Affairs. Candidates who have elected extensions carry out their regular full-time responsibilities, and continue to undergo annual evaluations for reappointment through the extended probationary period. In their tenure-year review, candidates who have elected extension are expected to meet only criteria stated in University-approved tenure policies and letters of appointment.

During the probationary period, a candidate for tenure may apply for leave under the Family and Medical Leave Act, or for leave without pay in the event of a birth or adoption, or a family illness (see pp. III-13, IV-16 & 17, and Appendix C). In such cases tenure eligibility will be delayed automatically, as specified below.

U. <u>SPECIAL PURPOSE FACULTY</u> (Dr. Maynard)

<u>Change in Language in University Handbook, Section III-1- Temporary Full-</u> Time Faculty

To accommodate the recommendations for Special Purpose Faculty that have been approved by the Faculty Senate and Academic Affairs, the following changes are required in the Handbook.

Bold type reflects changes in Section III-1 – Temporary Full-Time Faculty:

Full-time appointments, including Special Purpose Faculty appointments, to non-tenure track position are ordinarily made at the rank of instructor. These appointments are usually made for an academic year. Departments may submit requests for temporary appointments at higher rank or for periods beyond one year, but these requests are subject to the approval of the appointing authorities. Candidates for temporary full-time faculty appointments, including Special Purpose Faculty positions, are evaluated in the same fashion as are candidates

for regular faculty position. Salary floors do not apply to temporary full-time faculty including **Special Purpose Faculty**.

Change in Language in University Handbook, Section IV-4 - Temporary Faculty

To accommodate the recommendations for Special Purpose Faculty that have been approved by the Faculty Senate and Academic Affairs, the following changes are required in the Handbook.

Bold type reflects changes in Section IV-4-Temporary Faculty:

Full-time temporary faculty, **including Special Purpose Faculty**, are paid an academic year salary and are eligible for participation in the group health benefits plan, life insurance, and sick-leave accumulation. Full-time temporary faculty, **including Special Purpose Faculty**, are not eligible for the University retirement plan contributions, disability insurance, spouse fee waiver or dependent child fee waiver.

INTRODUCTION

The Code of Student Conduct contains the regulations governing the behavior of all students and student organizations at Indiana State University. These regulations are necessary to the orderly operation of the University and the maintenance of an environment designed to enhance the academic and personal growth of students.

Students and student organizations are expected to conduct themselves in accordance with these regulations. Furthermore, students and student organizations are to avoid any activity that aids, abets, or incites the violation of these regulations by others. Students and student organizations can be held accountable for violations committed by guests and associates.

The Board of Trustees has approved these regulations. Furthermore, the Board has empowered the President of the University and his/ her designees to enforce the regulations, adjudicate violations, and assign appropriate sanctions.

Numerous policies and procedures are referenced in the Code and will be enforced by the University. A partial listing of these policies and procedures is located in (page/section) with the appropriate web site identified. Students agree to abide by these policies as a condition of admission and are expected to know the regulations of the University and conduct themselves in harmony with these regulations.

The following definitions apply to terms found in the Code of Student Conduct:

- 1. The term "University" means Indiana State University.
- 2. The term "student" includes all persons taking courses at the University, both full-time and part-time, pursuing undergraduate, graduate, or professional studies and those who attend post-secondary educational institutions other than Indiana State University and who reside in University residence halls. Students who are not officially enrolled for a particular term or terms (up to two years after the last active enrollment) are defined as having a continuing relationship with the University and are considered "students."
- 3. The term "faculty member" means any person hired, appointed, or assigned by the University to conduct classroom activities.
- 4. The term "University official" includes any person employed by the University, performing assigned administrative or professional responsibilities. This term includes student employees such as Resident Assistants, Community Service Officers, etc.
- 5. The term "member of the University community" includes any person who is a student, faculty member, university official, or any other person employed by the University. The Director of Student Judicial Programs shall determine a person's status in a particular judicial process.
- 6. The term "University premises" includes all land, buildings, facilities and other property in the possession of or owned, used, or controlled by the University (including adjacent streets and sidewalks).
- 7. The term "student organization" means any number of persons who have complied with the requirements for University registration or recognition.

- 8. The term "All-University Court" or "judicial body" means any person or persons authorized by the President of the University or his/her designee(s), pursuant to policies established by the University, to determine whether a student or student organization has violated the Code of Student Conduct and to impose appropriate sanctions, including termination of student status or revocation of registration or recognition.
- 9. The term "shall" is used in the imperative sense.
- 10. The term "may" is used in the permissive sense.
- 11. The Director of Student Judicial Programs is that person designated by the President of the University or his/her designee to be responsible for the administration of the Code of Student Conduct.
- 12. The term "policy" is defined as the written regulations of the University as found in, but not limited to, the Code of Student Conduct, the Residence Hall Handbook, The University Handbook, and the Graduate and Undergraduate catalogs.

The Indiana State University Code of Student Conduct And Rights of Student

These regulations and other University policies and regulations referenced herein govern the conduct of individual students and student organizations. Students and student organizations will be held accountable for the conduct of their guests. Students and student organizations will be subject to these regulations for conduct occurring away from the campus when that conduct affects the educational interests or mission of Indiana State University.

SECTION I

MISCONDUCT ACTIVITIES WHICH SUBJECT A STUDENT OR STUDENT ORGANIZATION TO DISCIPLINARY ACTION

A. Offenses Against Academic Integrity

1. Academic dishonesty including plagiarism, cheating, submitting another person's material as one's own, or doing work for which another will receive academic credit.

The benchmarks of any great University are directly related to high standards of academic endeavor on the part of both teacher and student. It is in this relationship that truth and honesty are recognized as fundamental to a University community. The University expects both students and faculty to adhere to these principles and in so doing to foster the ideals for which the University was founded. Put simply, this means that the student will do his/her academic work without unauthorized aid or recourse to unauthorized means of any kind. Although most students have well developed concepts of honesty, professors may need to explain carefully to them the special hazards to academic honesty that work in a given discipline may present. Professors should also exercise care in planning and supervision of academic work so that honest effort will be encouraged.

Such breaches of academic honesty as may occur will be handled in the following way. In instances of cheating that appear to warrant a failing grade in a course, the professor will notify the department chairperson and the academic dean, in writing, of the circumstances. The student shall have the right of appeal of the professor's decision to both the dean and the Provost. After such an appeal, the instructor upon the advice of the department chairperson and the academic dean will determine the student's grade.

In instances of academic dishonesty in which the professor feels that action stronger than a failing grade in the course is indicated, the professor will report the situation to his/her department chairperson, the student's academic dean, and the Provost. When in their judgment such action is warranted, the student may be referred to the Office of Student Affairs, which will determine appropriate disciplinary action in keeping with procedures utilized in the handling of other types of student conduct situations.

All students are expected to maintain professional behavior, which includes the highest standards of integrity and honesty. For the student's benefit we include the following examples of academic dishonesty.

Academic dishonesty includes, but is not limited to:

- Plagiarism
- Cheating
- Fraud
- Using another person's material as one's own
- Knowingly allowing another person to use one's work as his/her own
- Plagiarism includes, but is not limited to:
 - 1. Copying and pasting text from on-line media, such as encyclopedias or journal articles, without attribution.
 - 2. Copying and pasting text from any web site without attribution.
 - 3. Transcribing text from any printed material, such as books, encyclopedias, newspapers, journal articles, and magazines without attribution.
 - 4. Simply modifying text from any of the above resources without proper citations. This includes lifting portions of another source and using them as your own work.
 - 5. Replacing a few selected words using a thesaurus.
 - 6. Using photographs, video, or audio without permission or acknowledgement.
 - 7. Using another student's work and claiming it as your own, even with the other student's permission. The latter is an act of collusion in which both students are plagiarizing.
 - 8. Acquiring work from commercial sources, including buying papers off the web or paying someone to do the work.
 - 9. Translation from one language to another without citations.

- 10. Submitting an essay or paper that was written for another class/purpose without the consent of the current instructor.
- 11. Using your previous work in any way as a basis for new assignments without citing the original work in the bibliography.

Cheating includes, but is not limited to:

- 1. Looking at another student's paper when taking tests.
- 2. Using notes of any kind during a test unless specifically given permission to do so by the instructor.
- 3. Working with others on individual take-home tests and individual projects/assignments unless specifically given permission to do so by the instructor.

Fraud includes, but is not limited to:

- 1. Providing false information on any academic document or record.
- 2. Falsely documenting internship hours in the field.

Academic dishonesty, plagiarism, cheating and fraud are bases for penalty. Academic dishonesty is a serious academic offense that is not acceptable at ISU

Adapted from the Department of Social Work Code of Student Conduct, ISU.

B. Offenses Against Persons

- 1. Physical abuse, verbal abuse, threats, intimidation, coercion, stalking, and/or conduct that threatens or endangers the health or safety of any person.
- 2. Use or possession of a firearm or object used as a weapon, dangerous chemical or explosive, or the use of any object in a manner that could be reasonably seen as having the potential to cause physical harm or the apprehension of such harm to another. The Director of Student Judicial Programs will determine the status of a weapon in any given situation.
- 3. Sexual assault or sexual harassment as defined in University policies or by state law.
- 4. Hazing, defined as an act or acts which endanger the mental or physical health or safety of another, or which destroy or remove public or private property for the purpose of initiation, admission into, affiliation with, or as a condition for continued membership in a group or organization.
- 5. Any activity that limits or restricts the freedom of a person to move about in a lawful manner.
- C. Offenses Detrimental to the Operation of the University.
 - 1. Conduct that is disorderly, lewd, or indecent.
 - 2. Acts that interfere with the freedom of expression of others.
 - 3. Disruption or obstruction of teaching, research, administration, or other University activities including public service functions.
 - 4. Furnishing false information to the University and/or the forgery, unauthorized alteration, or unauthorized use of any University document or instrument of identification.

5. Conduct that is a violation of the Criminal Code of the State of Indiana or of Federal Law, or that by its nature poses a threat to the welfare or safety of persons or property.

6. Misuse or unauthorized use of computing facilities or programs as defined by University

Computing Policies and Procedures. (See web reference on page XX).

7. Failure to comply with verbal and/or written instructions of University officials acting in the performance of their duties and made within the scope of their authority.

8. Violation of all other published University policies not specifically described in this

Code. (See web reference on page XX).

9. Engaging in solicitation of any type on University property without appropriate authorization. (See Section II).

D. Offenses that Compromise the Health and Safety of Others:

1. Intentionally initiating or causing to be initiated any false report, warning, or threat of fire, explosion, or other emergency.

2 Use, possession, sale or transfer of any unlawful drug or narcotic.

3. Drinking or possession of alcoholic beverages on University owned property or fraternity/sorority housing, except in designated areas listed below where students of legal age, according to the laws of the State of Indiana, may use or possess alcoholic beverages:

a. In student rooms when the student is living in Pickerl Hall and is 21 years of age

or older.

b. University Apartments when the student/resident is 21 years of age or older.

c. Any University facility, property, or area under the governance of the University with the approval of the President or his/her designee.

4. Providing alcohol to persons not of lawful drinking age.

- 5. Igniting or burning materials in a manner that reasonably could or actually does cause a fire.
- 6. Engaging in gambling, wagering, or other games of chance in violation of the law.

E. Offenses Against Property:

1. Theft of property or services or knowingly possessing stolen property.

2. The intentional and/or reckless destruction or damage of University property or the property of others.

3. Unauthorized use, entry, occupancy, or possession of University facilities, structures, or property.

F. Offenses Against the Judicial Process

1. Conduct that is in contempt of the All-University Court and/or Student Judicial Programs, including but not limited to failure to obey an order to appear before the All-University Court or the staff of Student Judicial Programs, or the falsification, distortion, or misrepresentation of information before the All-University Court or the staff of Student Judicial Programs.

SECTION II

POLICY ON SALES AND SOLICITATIONS A.

Sales and solicitations may be conducted on campus by an officially registered or recognized student organization. Off-campus charitable, not-for-profit, and commercial enterprises offer programming opportunities that often include sales. Such programs may be brought onto campus under the sponsorship of a registered or recognized student organization. All sales and solicitations must comply with University regulations and policies, as well as local, state, and federal laws and ordinances.

- 1. Sales or solicitations in residence halls must be approved by Residential Life.
- 2. Sales or solicitations conducted anywhere on campus except in the residence halls must be approved by Student Life Programs. In addition, use of a facility for the purpose of sales or solicitations must be approved by the person charged with primary responsibility for use of that facility. (Names of such persons are available in Student Life Programs.)
- 3. Individual students who wish to sell or solicit on campus may do so by renting space in the Hulman Memorial Student Union or by conducting the sale in the privacy of their own residence hall rooms or University Apartments residence, provided such sales have been specifically approved in accordance with the Residential Life guidelines.

B. POLICIES FOR POSTING NOTICES

The University provides facilities for the posting of University related and private notices under the following criteria:

- 1. Notices must have the name, address, and telephone number of an authorized organization representative (or individual if not affiliated with an organization) clearly printed on the back of the notice.
- 2. The notice cannot promote any activity in violation of University regulation or policy, or federal, state or local law or statute.
- 3. Hulman Memorial Student Union and Residential Life have limitations on the size of notices. Users should contact the Directors of those facilities concerning these limitations. In all other areas, posted notices may be no larger than 18 inches by 24 inches.
- 4. Outdoor displays cannot be nailed to trees or other structures or objects. The use of string, tape, or wire is suggested. No stakes or postholes may be used without the written permission of Facilities Management.
- 5. Chalking with water soluble chalk is restricted to flat, horizontal walkways in open areas that will allow rain to eventually wash the chalk away. Chalking is prohibited on benches, walls or other vertical surfaces. Chalking is not allowed on the brick paver walkways.

- 6. Posters may not be attached to the sides of buildings. Banners may be hung from buildings if approved by the building supervisor and Facilities Management. Posters and notices may not be placed on glass (entry) doors or windows.
- 7. Private parties may post notice of meetings and services as long as the above criteria are followed. Posters are removed after two weeks or at the end of the effective date of the posted message, whichever comes first.
- 8. Priority is given to those notices posted by University departments and by registered/recognized student organizations.

The University may remove and discard any outdated notice, or any notice posted in violation of the criteria outlined above.

SECTION III PROCESS AND THE RIGHTS OF STUDENTS

A. GENERAL OVERVIEW OF PROCESS FOR HANDLING CONDUCT SITUATIONS
The Board of Trustees of Indiana State University has adopted University policies and
procedures to provide an orderly environment whose purpose is the academic and personal
growth of students. The University administration is responsible for providing the process for
addressing violations of these policies.

A process has been developed for addressing student conduct situations at three levels: hearings with minimum due process, conferences with Student Judicial Programs staff, and full due process hearing.

Minimum Due Process. Conduct Discussion or Residence Hall Probation may be utilized by a Student Judicial Programs professional staff member or residence hall head staff member when a complaint is received for an alleged violation that is a first offense, minor in nature, or addresses a violation that is related to residence hall contractual issues. If a student is found responsible, it will not result in a change of student status. The accused student is informed of the complaint by the appropriate staff member and is given the opportunity to discuss the alleged violation. The student may admit to the violation or may deny involvement. If the student is not satisfied with the outcome of the hearing, he/she may have the complaint referred to the Director of Student Judicial Programs and request that the matter be heard in Conference.

Should the student be found responsible for the violation, a record of the incident is maintained in Student Judicial Programs or in the residence hall area director's office for one (1) calendar year. If during that year, the student becomes involved in another conduct situation, the Conduct Discussion or Residence Hall Probation record will be utilized in determining at what level the new allegation(s) will be addressed.

Conference. A conference hearing addresses behavior that is too serious to be processed with minimum due process. A conference would not require the preparation of charges or hearing. A Student Judicial Programs staff member would meet with the accused student and discuss the alleged violations. The facts surrounding the case would be reviewed with the student and a

decision reached. If the student and staff member do not agree, the student may request to have the complaint referred for a full process hearing. Charges will be filed against the accused student and he/she may request a hearing with the All-University Court.

Conduct Adjudication. Full due process is used for all alleged violations that may result in a change of student status. The process contains three fundamental steps: (1) presentation of the charges, (2) hearing and decision by All-University Court, and (3) action by an administrator. An appeal opportunity is available for the accused student or complainant upon receipt of the decision.

B. RIGHTS IN DISCIPLINARY SITUATIONS

The Board of Trustees in keeping with procedural guidelines has accorded students rights in disciplinary situations. These rights may be found in written detail in the Student Government Association Constitution and in the Conduct Adjudication Information pamphlet, which is given to a student at the time of presentation of written charges. Basically students have the right:

- 1. To examine all written information pertaining to the alleged violation;
- 2. To a fair hearing:
- 3. To know whether statements made in disciplinary situations can be used in All-University Courts, administrative procedures, or civil courts;
- 4. To bring an advisor from the University community to a hearing (the accused student may use legal counsel as an advisor when facing criminal charges for the same occurrence);
 - 5. To appeal decisions of the hearing based on specific grounds defined within this process.

C. CONDUCT ADJUDICATION PROCESS

- 1. Presentation of Charges. A student who is accused of an alleged violation of a University policy receives written notice and materials outlining the allegations against him/her and the appropriate charges drawn from the allegations. The student also receives materials that provide a thorough explanation of the conduct adjudication process that includes a review of rights of students during disciplinary proceedings, a detailed explanation of possible actions, and a description of the preservation of and release of information from the conduct records. The student is given two (2) days to present his/her plea to Student Judicial Programs.
- 2. Hearing. All hearings provide the opportunity for the accused student to respond to the charges, to change his/her plea, to present witnesses, and to raise questions. Hearings provide the opportunity for the complainant to present the allegation, to present witnesses, and to raise questions. An All-University Court hearing panel will, through questioning, seek to arrive at the truth. Should a student fail to appear at a scheduled hearing, after proper written notification, the hearing will be conducted in his/her absence.
 - 3. Presentation of Decision. An administrator meets with the accused student to communicate

the decision and to take the action of a hearing panel. The student is apprised of the decision from the hearing concerning his or her responsibility. A detailed explanation is given of the action and its effect on the student, which may include probation, stipulations, and future expectations for the student's behavior. The student is informed of the right to appeal and the procedure to follow. The complainant is also apprised of the decision and given information about the appeal process.

D. TYPES OF DISCIPLINARY ACTIONS

The actions that may be taken when a student is found in violation of University regulations or public laws range from charges dropped up to and including expulsion from the University. The action taken depends upon the severity of the violation, the degree of involvement of the student, the individual circumstances of each case, the student's conduct record, and the student's academic progress.

- 1. Charges Dropped/Not Responsible. The charges may be dropped if there is insufficient evidence to support the charge. If evidence is presented during the hearing that shows a student has not committed the violation, then he or she is found not responsible. All written materials pertaining to the allegations against the individual are destroyed.
- 2. Judicial Probation. This action is a probationary status that would notify a student that his or her actions are of a serious nature and that a formal sanction is justified, but the student is not removed from good standing. The probation could include additional stipulations, and would be assigned for at least the equivalent of one full semester. A written record is maintained for (1) one calendar year after the date of the action, pending no further violations.
- 3.Deferred Suspension. Formal disciplinary action near suspension, and includes a review of a student's behavior for a specific period of time. The student is removed from good standing at the University, for not less than the equivalent of one full semester. The sanction may carry other restrictions and stipulations. The student must meet all conditions and submit a written request to be returned to good standing. A subsequent violation could be cause for suspension. A written record is maintained for three (3) calendar years after the date of the last action taken, pending no further violations.
- 4. Suspension. This action indicates that a student is excluded from the University for one (1) or more semesters, depending upon the severity of the violation. The sanction includes a ban from entering the environs of the University property and a hold placed on registration. Parents of financially dependent students will be notified. The record is maintained permanently.
- 5. Interim Suspension. This action may be used to temporarily remove and exclude a student from the University community, when the student's action or threat of action indicates serious threat to the welfare and safety of persons or property. No hearing is necessary before the action is taken, but a hearing panel of the All-University Court will review the suspension within five (5) business days of the effective date. Full due process, including a hearing, may be granted at a later date. If the suspension stands, the record is kept permanently.
 - 6. Expulsion. This action means permanent termination of student status. The record is

maintained permanently.

E. RECORDS POLICY, STUDENT JUDICIAL PROGRAMS

The Family Education Rights and Privacy Act (FERPA) affords students and eligible parents the right to "inspect and review the education records of the student." (section 99.10 (a). Disciplinary records maintained by the University are considered education records as defined by this law. Parents of a dependent student as defined by the Internal Revenue Code will receive notification of sanctions of certain violations of the **Code of Student Conduct** (See section III of the *Code of Student Conduct*, subsection D. "Types of Disciplinary Action" for details.)

Indiana State University is responsible for maintaining these records, including the development of procedures necessary to safeguard the confidentiality of the records. Student Judicial Programs has established guidelines in order to afford students and eligible parents access to the disciplinary record, while exercising the institutions responsibility to confidentiality required by law. A dependent student who desires that his/her parent review his/her disciplinary record must provide written consent to Student Judicial Programs.

All materials in the disciplinary record are the property of Indiana State University. This includes the recordings of hearings, in printed summary as well as audio tape recordings of hearings, and written recommendations or decisions reflecting findings of guilt and innocence and the sanctions assigned to those students found in violation. The University will not release these materials to any party, unless compelled to do so through a court order. Students may request an opportunity to review those records by scheduling an appointment with Student Judicial Programs.

Student Judicial Programs is charged with the responsibility for the destruction of records based on the schedule described in Section III, D. of the *Code of Student Conduct*. Tape recordings of hearings will be maintained until the final decision of the University appellate process or the failure of the student to file appeal within the deadline specified by the University.

Those materials provided an accused student (the complaint, witness statements, charges, etc.) become the property and the responsibility of the accused student. These materials are provided the accused student in accordance with fairness and University due process. (Reference the FERPA web page @ XX).

F. APPEALS

An accused student or the complainant has the opportunity to appeal the decision and action of a hearing body. Appeals must be presented in writing within five (5) calendar days of the receipt of the decision from the administrator taking the action. Details of the procedure are explained in the written materials describing the conduct adjudication process, which is distributed with the presentation of charge. The appeal process is also explained when the decision is given.

One or more of the following grounds must be established to appeal:

1. To determine whether the original hearing was conducted fairly and in conformity with the

prescribed procedures giving the accused party a reasonable opportunity to prepare and to present a rebuttal of those allegations;

- 2. To determine whether the sanction(s) imposed is appropriate for the violation of the Code of Student Conduct the student is found to have committed;
- 3. To consider new evidence that is sufficient to alter a decision (conduct action) or to offer relevant facts not brought out in the original hearing because such evidence and/or facts were not known to the appealing party at the time of the original hearing.

G. VIOLATIONS OF REGULATIONS BY A STUDENT ORGANIZATION

As in the case of a violation of a conduct regulation by an individual, a complaint may be filed accusing a student organization of a violation. Upon receipt of such a complaint, a charge will be given to the president or highest-ranking officer in the organization, the organization advisor, and the national office of the organization (if applicable). A hearing will be conducted, and a decision will be given and disciplinary action taken. All proceedings will parallel those provided by Section III, C. The filing of charges against and taking disciplinary action with a student organization does not preclude the filing and taking of disciplinary action with individuals involved in the same violation(s).

H. TYPES OF DISCIPLINARY ACTION APPLIED TO A STUDENT ORGANIZATION

Charges Dropped/Not Responsible

- 1. The charge may be dropped if there is insufficient evidence to support the charge.
- 2. The charge will be dropped if there is evidence presented during the hearing that shows the organization is not guilty of the charge.

Conduct Warning

- 1. Notification to organization that the conduct of its members has not been in keeping with the expectations of the University.
 - 2. A thorough explanation of University policies is given.
- 3. The student officers and University advisor of the organization are instructed that further violations of University policies could be cause for additional disciplinary action.

Probation

- 1. This action is a formal probationary status during which the organization will have certain restrictions placed on it for a period of time.
- 2. Restrictions and provisions of the probation are individualized to the particular needs of the organization; these may include restrictions on social events, on use of University facilities, or on participation in campus-wide events (i.e., Homecoming or Tandemonia).
 - 3. Charges for any damages or costs incurred as a result of a violation may also be assessed.

- 4. Any further violation of University regulations or probation restrictions while on probation means that an organization subjects itself to further disciplinary action.
- 5. University officials with responsibility for adherence to restrictions placed on the organization will be notified, as well as the persons responsible for registration of student organizations. Additionally, national offices of affiliated student organizations will be notified.

D. Review of Recognition/Registration of Student Organization

- 1. This action indicates that an organization's standing as a registered student organization of the University is in jeopardy and a formal review of the recognition/registration of the organization is being requested of the body with jurisdiction.
- 2. Action from such a review may ultimately result in revocation of recognition/registration of a student organization.
- 3. For those organizations with national affiliations, a request for formal review will also be made to the national office.

SECTION IV

YOUR RIGHTS AS A STUDENT UNDER THE FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT

It is the policy of Indiana State University that all practices and procedures related to the education records of students shall be in accord with the provisions of the Family Educational Rights and Privacy Act of 1974, as amended. This policy has been implemented by the development of guidelines for record keepers and a listing of the education records on campus. Both the guidelines and the listing are available for review by students as indicated below. The following questions and answers provide an outline of students' rights under the Act.

Q. As an enrolled student at Indiana State University, what rights do I have regarding my University records?

A. You have the right to inspect and review all your records that meet the Act's definition of "education records."

O. What is the definition of "education records"?

- A. Education records are all records maintained by the University about you. There are eight exceptions:
 - a. Personal notes of Indiana State University staff and faculty;
 - b. Employment records of all employees whose employment is not dependent upon student status;
 - c. Medical and counseling records used solely for treatment;
 - d. Records in the Public Safety Department;
 - e. Financial records of your parents;
 - f. Records that contain only information relating to a person after that person is no

- longer a student, such as alumni records;
- g. Confidential letters and statements of recommendation for admission, employment, or honorary recognition placed in your records after January 1, 1975, for which you have waived the right to inspect and review.

Q. Is there any situation in which the University may insist that I waive my rights?

A. Under no conditions may you be required to waive your rights under this Act before receiving University services or benefits.

Q. Where are my records kept?

A. Records are not maintained in a single location on the campus. Requests to review your records must be made to each of the offices that maintain your records. In some instances you may be required to submit in writing your request to review a record; the Act allows up to 45 days for honoring such a request. Most likely you have education records in the offices of the Registrar, the dean of your school or college, your major department, and any other campus offices with which you have been involved such as the Student Academic Services Center, Student Financial Aid, Residential Life, and Student Judicial Programs. A list of the kinds of education records maintained on campus, their location, and titles of personnel responsible for those records is a part of the University Policy for implementation of this Act and is available in Parsons Hall, room 203.

Q. What if I do not agree with what is in my records?

A. You may challenge any information contained in your "educational records" which you believe to be inaccurate, misleading, or inappropriate. This right does not extend to reviewing grades unless the grade assigned by your professor was inaccurately recorded in your records. The first step in challenging the record is to request of the record-keeper or the person responsible for placing the data in the record that the record be amended. If the request to amend the record is denied, you may file a request for a hearing; a hearing officer will be appointed; and a decision will be made. If the record is not amended as a result of the hearing, you may insert in the record an explanation of your reasons for believing the record to be inaccurate, misleading, or inappropriate. The explanation becomes a part of the record until the record itself is destroyed, and the explanation you have written is included every time the contents of the record are disclosed. You also have the right to file complaints with the Family Educational Rights and Privacy Act Office, Room 4511, Switzer Building, 400 Maryland Avenue SW, Washington, D.C. 20202.

Q. May I determine which third parties can view my education records?

- A. Under the Act, your prior written consent must be obtained before information may be disclosed to third parties unless they are exempted from this provision. These exemptions include:
 - a. Requests from Indiana State University faculty and staff with a legitimate educational "need to know" (except employees of the Public Safety Department);
 - b. Requests in accordance with a lawful subpoena or court order;
 - c. Requests from representatives of agencies or organizations from which you have received financial aid;
 - d. Requests from officials of the educational institutions in which you intend to enroll;

- e. Requests from other persons specifically exempted from the prior consent requirement by the Act (certain Federal and State officials, organizations conducting studies on behalf of the University, accrediting organizations);
- f. Parents of a dependent student as defined by the Internal Revenue Code will receive notification of sanctions of certain violations of the Code of Student Conduct (See Section III, D., of the Code of Student Conduct, "Types of Disciplinary Action" for details); and
- g. Requests for directory information (please refer to the next question for an explanation).

Q. What is meant by the term "directory information"?

- A. The University, in accordance with the Act, has designated the following categories of information about you as public unless you choose to exercise your right to have this information withheld. These categories are:
 - a. Full name;
 - b. Address, campus, home, and e-mail;
 - c. Telephone listing;
 - d. E-mail address;
 - e. Major field of study, includes teacher certification majors and minors;
 - f. Participation in officially recognized activities and sports;
 - g. Weight, height, and position of members of athletic teams;
 - h. Dates of attendance (including current classification and year, matriculation, and withdrawal dates);
 - i. Degrees, awards, and honors, and dates received including honor roll designation;
 - j. The most recent previous educational institution attended; and
 - k. Full or part-time status.

Q. What kinds of inquiries does the University receive for "directory information"?

A. The University receives many inquiries for "directory information" from a variety of sources including friends, parents, relatives, prospective employers, graduate schools, honor societies, licensing agencies, government agencies, and news media. Please consider very carefully the consequences of any decision by you to remove these items from the list of "directory information." Should you decide to inform the University not to release this "directory information," any further requests will be refused. For example, if you direct the University not to release your directory information, the University could not release your telephone number or address to a family member wishing to notify you of a serious illness or crisis in the family. A prospective employer requesting confirmation of your major field of study, address, or date of birth would also be denied access to such items should you withdraw them from the list of "directory information." The University will honor your request to withhold the items listed above but cannot assume responsibility to contact you for subsequent permission to release them.

Regardless of the effect upon you, the University assumes no liability for honoring your instructions that such information be withheld.

Should you wish to file a form withdrawing information in the "directory" classification, you should complete the form developed for this purpose, which will be available for your use in the Office of Registration and Records at registration time. After you have filed this form, the Registrar will notify the appropriate University offices and begin to comply with your wishes as

soon as possible.

Q. Where can I find out more information about the provisions of the Act?

A. Several documents are available in room 203 of Parsons Hall for further study. They include: guidelines for record keepers on campus in implementing provisions of the Act; a list of education records on campus arranged alphabetically by classification and with location and custodian identified for each; the Family Educational Rights and Privacy Act of 1974 as amended; and Department of Health, Education, and Welfare Final Rule on Education Records. If you have questions or if you need assistance in understanding and exercising your rights under the provisions of the Act, assistance is available in the same office.

Q. Whom should I contact to make a complaint?

A. When you believe the University is not complying with the Act, please direct your comments to the Office of the Vice President of Student Affairs, room 203, Parsons Hall.

Guidelines for Involuntary Medical Withdrawal

- 1. The Involuntary Medical Withdrawal process will be initiated when the student's condition involves one or more of the following:
 - Causes the student to engage in behavior that poses a significant danger of causing harm to self or others or to substantial property rights.
 - Involves a condition that threatens public health.
 - Renders the student unable to engage in basic required activities necessary to obtain an education.
 - Directly and substantially impedes the lawful activities of others.
 - Interferes with the educational process and orderly operation of the University.

Medical Withdrawal should not be imposed when judicial, academic, or other responses are readily available and the student's situation can be addressed through those avenues. Furthermore, when possible and appropriate, efforts will be made to persuade the student to voluntarily withdraw and to follow a course of treatment needed to resume student status.

2. The Assistant Vice President for Student Affairs and/or the Director of Student Judicial Programs may recommend that a student be withdrawn for medical reasons under the above criteria.

The student will receive written notice of this recommendation and a copy of the procedures used to determine if this action should be taken.

This recommendation will be cause for the Medical Withdrawal Committee to convene and review the recommendation within five (5) working days. Prior to this hearing, the student may be required to submit to a medical or psychiatric evaluation (paid for by the University). The results of this evaluation will be available for review at least two days before the hearing. The student may review this evaluation by scheduling an appointment with a designated member of the Medical Withdrawal Committee.

The Medical Withdrawal Committee is comprised of the Director of the Student Counseling Center, the Director of the Student Health Center, and the Assistant to the Vice President for Student Affairs. The student may be assisted at the hearing by an advisor of his/her choosing. The name and relationship of the advisor to the student must be communicated to the Committee in advance of the hearing.

Should the committee agree with the recommendation, the student will be medically withdrawn from the University. The committee will prepare a written record of the hearing and will prepare a written decision. This decision will specify the effective date of the withdrawal, and will outline specific requirements the student must meet in order to apply for re-admission to the University. The student must be academically, financially, and judicially cleared for continued enrollment at the

University. The decision should clearly reflect the goal of designing steps to assist the student in correcting the debilitating condition and returning to active enrollment.

The University will communicate notice of the withdrawal to the parent, guardian, or person designated as a contact person by the student. The University is authorized to make this notification under the health and safety clause of the Family Educational Rights and Privacy Act.

The student has two (2) working days to file a written appeal of this decision with the Vice President for Student Affairs. The Vice President's decision is final.

3. Interim Medical Withdrawal will be invoked when the danger to the student and/or others is imminent, or when the student has failed to undergo an evaluation for the purposes of assessing his/her condition as directed by the Assistant Vice President for Student Affairs or by the Medical Withdrawal Committee.

A hearing will be scheduled before the Medical Withdrawal Committee within two working days of the action. The student will receive written notice of this hearing and is invited to attend. Aside from attendance at this hearing, the student is barred from campus.

This is an administrative hearing and does not require the process found in criminal hearings. The Committee will determine appropriate action based on a preponderance of evidence.

Should the committee determine that the Interim Withdrawal is not warranted, the Office of Student Affairs will provide all necessary assistance in returning the student to class.

Should the committee determine that the Interim Withdrawal is justified, the action is affirmed. The student has 48 hours to file an appeal of this decision with the Vice President for Student Affairs. This appeal is a review of evidence gathered in the committee deliberation and does not involve a hearing. The Vice President can ask to meet with the student if he/she deems this necessary to the review. The Vice President's decision is final.

- 4. The committee recommends an appropriate date for the withdrawal to become effective. The effective date may be backdated to accurately reflect that point in the term when the student's condition impeded his/her ability to meet the demands of academic responsibility. If this is not a pertinent concern, the committee may establish the date of action as the effective date of the withdrawal.
- 5. The student will be asked to sign release of information documents authorizing the committee to review and share as appropriate information regarding the student's condition. Should the student refuse to provide such authorization, refuse to undergo evaluation, or fail to comply with requests for information pertinent to this

review, the committee may draw a negative inference and affirm the recommended action.

6. The student will be required to submit a completed questionnaire from his/her attending physician or licensed mental health professional as a requirement of the petition to re-enter the University. The Medical Withdrawal Committee may further request that the student undergo an evaluation with a medical professional designated by the committee. This evaluation must be completed and the student is responsible for the cost of this evaluation. Again, the student must authorize that this information be provided to the Committee and shared as the committee deems appropriate. The student is not required to attend this review.

The committee will determine after a review of relevant information if the student no longer suffers from the condition that caused the withdrawal, or that continued treatment will prevent a recurrence of the condition.

ARTICLE V The Executive Branch

Section 1:

The executive officers of the Student Government Association shall include the President, Vice President, Chief of Staff, Treasurer, Secretary and other officers as deemed necessary by the Senate. All executive powers are vested in such officers.

Section 2:

The Student Senate shall be composed of Senators with voting powers from each Academic Colleges expect Graduate Studies and including Student Academic Services, and speaking seats which shall not have voting power.

ARTICLE VI The Legislative Branch

Section 5:

- 2. The Secretary shall have no vote in the Senate.
- 3. The Secretary shall take minutes of Senate meetings and perform other duties as set forth by the Student Government Code.

Section 7:

Senators must be enrolled in the college they represent.

ARTICLE VIII Elections

Section 1:

An election for all elected SGA positions will be held on an annual basis in late February or early March.

Section 6:

A. A number of students from each Academic College except Graduate Studies and including Student Academic Services. This number shall be determined by the following formula:

At the beginning of each spring semester, based on the total population of each college from the spring 10-day report, the election commission will determine the number of senators for each college based on a 1:250 ratio.

INFORMATION/DISCUSSION ITEMS

A. Budget Overview, 2004-05

Vice President Floyd and Diann McKee outlined the budget process which provided for interaction about the needs of all departments. Following budget hearings, a series of meetings were held with the President's Cabinet. There were budget challenges and approximately \$925,000 had to be reallocated to supplement the 1.3 per cent in new money for 2004-05. The new additional dollars will cover technology, library acquisitions, insurance and utility cost increases, and the elimination of the two-year wait for TIAA-CREF participation for faculty and EAP staff. The budget will incorporate a two per cent salary pool for increases for faculty and staff. Vice President Floyd thanked all those who participated in the budgeting negotiations and presentations.

Several trustees expressed appreciation for the very explicit detail of the budgeting process and information and for the apparent widespread cooperation and participation solicited.
